Non-Discrimination Statement

What is discrimination?

Discrimination is unfair or unlawful treatment of a person or group because they are part of a defined group, known as a protected class. Discrimination may include treating a person differently or denying someone access to a program, service, or activity because they are part of a protected class, or failing to accommodate a person?s disability. Discriminatory harassment is verbal or physical harassment based on a protected class.

What is a protected class?

A protected class is a group of people who share common characteristics and are protected from discrimination and harassment by federal, state, or local laws. Protected classes in Seattle Public Schools are those groups identified in the Non-Discrimination Statement above, such as sex, race, etc.

How do I file a complaint about discrimination regarding Meal Benefit Application?

If you believe that you or your child has experienced discrimination regarding your Meal Benefit Application, , you have the right to file a formal complaint. You can call the USDA at 866.632.9992

The AFUHSD Food Service Department will not handle or file your complaint.

You may also file a program discrimination complaint with the USDA. You may obtain a complaint form by sending an email to

<u>CR-Info@usda.gov</u>. You or your authorized representative must sign the complaint form. You are not required to use the complaint form. You may write a letter instead. If you write a letter, it must contain all of the information requested in the form and be signed by our or your authorized representative.

The CNP operator shall not accept any complaints of discrimination, whether written or verbal, relating to the Child Nutrition Programs.
